GARDEN CLUB OF AMERICA ANNUAL MEETING

DISNEY WORLD, ORLANDO, FLORIDA

MAY 5-8, 2001

Six hundred women from all over the country descended on Zone VIII in Orlando with, I'm ashamed to say, tongue in cheek anticipation: a weekend with Mickey for all those sophisticated garden ladies? Indeed! We were in the former land of cotton, cattle and chickens, now turned into cartoons, exotica, orange groves and tourists. In three days six hundred women had revised their views and were not only delighted with what Walt's World had offered, but also impressed with the skill and expertise that Florida had used to adapt Disney to GCA expectations!

Mary Kendrick, Nancy Vincent and Libby Mossman, outfits and Plant Exchange bag in tow, trekked into an elegant Disney Yacht and Beach Club. Its many rooms were hidden somewhere, but not up as were those of the Swan and the Dolphin hotel in the distance . We supped on fine fare at the Flying Fish on the Board Walk, and braced for the meetings beginning the next (Sunday) afternoon.

Sunday morning we headed for the Animal Kingdom, opened in 1998. We began with the Kilimanjaro Safari, marveled at the six huge tigers lolling in decaying temples and lushly vegetated grounds in Asia, and beat off 3D Bugs and Acid Zaps in the Bug's World experience. Now we know why the TV ad showing the executive pleading with his parents to take him to Orlando is a better advertising spot than we thought!

In the afternoon, we began to justify our existence by attending the Presidents' and Delegates' workshops. We listened to a brief overview of national committees (NAL/Conservation/Programs/Garden History and Design), and a description of the exciting Casey Tree Project in Washington that the GCA has been asked to oversee. Our table of ten from Tennessee, Ohio, California, Oregon and elsewhere got to work comparing notes on the need to stagger and coordinate flower show dates and work on more flexible schedules. It was revealed that some California clubs actually fined members who did not attend meetings without a valid excuse! We discussed the fact that some zones, at their discretion, held zone meetings only once every two years. And it was interesting to discover that many clubs subsidized all of the national and zone meeting attendance expenses. It was apparent that all clubs really were working on the same issues, had the same problems and concerns and found that communication of this sort was the key to addressing them.

Sunday dinner took us to Epcot: floating flower rings at the Odyssey (which were self-watering), and a brilliant display of fireworks. The Power of the GCA and POWWOW (3000 Insurance agents shared Epcot) enabled the Mouse to close the usually open Epcot for our use alone that night, and to open the usually closed Animal Kingdom for us the next night!

Monday morning's Business Meeting, chaired by acting president Bobbie Hansen, began with a note from Mrs. Waller, among those of other past president's. We were proud to be in the company of clubs that could claim one of their members as a GCA President! The keynote speaker, Leslie Smith, a member of the GC of Palm Beach for 30 years, spoke eloquently, describing her inability to grow impatiens -- there is a club niche for everyone! She mentioned that all new construction in Florida now mandates 50 percent xeroscaping, and spoke about the campaign to save the Everglades that we were to hear more about the next day. Leslie has been the dynamic mayor of Palm Beach for years.

The Founders Fund winner is -- Daphne Root take note -- the EcoTarium Meadow in Worcester, Mass. Daphne's daughter, Dolores, is Director of Exhibits and Special Events there. An elegant tribute was made to Netta Lockwood, a former GCA Member at Large. Many of us who knew her probably are not aware of the high esteem in which she was held by horticulturalists all over the country. A huge photo of Mary and Linda receiving last years first annual GCA Public Relations Award graced the overhead screens for a long time before the awarding of this year's prize to the ladies of Palm Beach, Zone VIII, for the book produced by their club featuring great gardens of their city.

Tears came to many eyes with the extraordinary speech given by the incoming GCA President, Anne Frierson. She recalled her childhood days in the woods near Athens, Georgia, showing so much of her personal and special commitment to the need to preserve our land for our children and to educate them to become nurturers of nature. We were asked to act Nobler and Bolder, to Educate, not Dictate, and to communicate that there is hope for Nature only **through** the actions of Man, although Man has been the despoiler of much of it. The next GCA Annual meeting will be hosted April 7 -9, 2002, by the granddames of Dallas. We will need to get out our cowboy boots and jewels for this one!

Monday Night took us back to the Animal Kingdom with the same "Bug" 3D special, which amazingly enough still had impact. Bugs are beneficial! There was no need for 'Off', despite the fact that Disney uses 80 percent Integrated Pest Management methods, and unleashes thousands of bugs weekly to eat their way through the undesirables! Lacewings, lady bugs and praying mantises rule here. Exotic stir-fries in the Asian Kingdom and the night views of Disney's artistry ended our evening.

Cinder Dowling, Chair of GCA's Horticulture Committee, opened Tuesday morning's Horticulture Meeting, speaking of the long-awaited Plant Exchange video, soon to be available for club viewing. We, alas, had all of our plants passed, and somehow in the wee hours of the night a white fly was found on two of them. We had to spirit them out of the show room as did some others I may add, but this didn't detract from the spectacle of the hundreds of plants on display, and from the great appearance of the plants raised by our members to send down. We received 13 points despite the bugs!

Acer pensylvanicum received the 2001 Freeman Plant Medal, proposed by Zone III's JoAnne Lenden and others. It was interesting to note that the incoming Horticulture Chair, Laura Gregg, cautioned all growers to rise to the "correct level of emotional stress and no more" when growing. This means: have fun and learn something but don't make yourself crazy! If it lives, it lives!

Katie Moss Warner, from Phillipsburg, N.Y. spoke next. A past horticulture director of all 30,000 acres of DisneyWorld, Katie is now at the Harvard Graduate School of Landscape Design and is a new GCA Member at Large. She had no trouble keeping us all awake as she explained why DisneyWorld is considered to be a model for Land Stewardship, refuting its often reviled cartoon/land spoiling/aquifer-polluting image. She made a credible case. Disney as a corporate ally in greenspace is a new and interesting concept. She spoke of the less subtle flower choices for some of the displays, but reasoned that these impressed many of those attending, and in their own way were making garden converts of many of their visitors.

The works of art created in the landscapes of the animal kingdom and many other areas are wondrous to behold. Katie spoke of convincing the management of DisneyWorld to hire more skilled garden labor, proved to them the ultimate cost savings of teaching good horticultural practices and learning how to care for and conserve existing plantscapes resulting in less replacement, less water used, fewer pesticides, more recycling and more use of renewable resources. They use wood palette mulch instead of cypress. Do we really need to mulch so much anyway?! They now have weather-driven computerized watering systems and use less fertilizer to produce less grass growth and fewer clippings. Gardens, flowers and general atmosphere turn out to be one of the main reasons why many people return to DisneyWorld. She encourages the education of children through school garden programs and through the use of community gardens.

Judy Boggess, Chair of National Affairs and Legislation, spoke on Thinking Globally and Acting Locally to clean up air toxins, maintain crop diversity, stop shrinking forests, and encourage Eco-Tourism. Irene Davis, Conservation Committee Chair, spoke of Maine coastal and fisheries issues and of a terrific invasive plant slide show entitled "Not In My Garden."

The keynote Conservation speaker was every bit as engaging as Katie Moss Warner. Steward Strahl, President/ CEO of the Florida Audubon Society, and Vice-President of the National Audubon Society, spoke of efforts to restore the nation's most endangered ecosystem, the Everglades. In Florida, people come to see wildlife more than those who come to see, for instance, the scenery of the Rocky Mountains.

The ecosystem supporting indigenous birds and animals is water driven and because of years of flood water diversion away from the Everglades, Lake Okechobee and the Kissimee River Valley, their natural habitats have been drying up at an alarming rate. Surface water treatments and pollution have affected the natural aquifer system. Florida's twenty billion dollar tourist industry is endangered; there is little water for fire prevention and fighting and what is left of local farming is fast disappearing.

Recent legislation has helped restore natural water filtration and the habitats of the animals they are trying to save from extinction. Tourist dollars are needed to augment inner city clean-up and increase the water supply necessary to support the food for fast growing urban populations.

Tuesday afternoon, we boarded buses to tour the greenhouses and growing areas behind all of the miracles of presentation. Good lessons were learned in container planting, orchid maintenance and the use of pesticides. What an army is needed to back up the smooth flowing and "never a dead leaf" exterior!

Zone VIII's Annual Meeting culminated in a glamourous Awards Dinner in the Grand Ball Room. Flower arrangements were noteworthy, conversation flowed with old acquaintances and new and well-deserved awards were received. Among these, the Distinguished Service Medal went to the New England Wild Flower Society. The Eloise Payne Luquer Medal was awarded to Dr. Harrison Leslie Flint. Dr. Flint's work at Purdue University, the Arnold Arboretum and his numerous publications mark only a few of his qualifications as an "outstanding plantsman and an outstanding human being."

Wednesday morning, three exhausted Bedfordites drove to the airport in Mary's rented car and, after a few minor hitches, boarded the plane for LaGuardia. We had gained a lot: connections with old friends, contact with new ideas, and three days of novel sights and sounds. Those who had not been to that part of Florida **without** children before came away with a new respect for the Zone VIII land and ladies who receive an A+ for four flawless days of fun.

STANDING COMMITTEES

ANNUAL REPORTS, JUNE 2000 – JUNE 2001

CONSERVATION AND CIVIC AFFAIRS

The Conservation and Civic Affairs Committee continues to emphasize the importance of land preservation and environmental education. This year, the community garden project, local land preservation initiatives and our guest lecturer, Shepherd Ogden, dramatized how we can affect change on a local level as concerned citizens or as educated consumers.

Town Meetings

We thank Tanya Lowe for continuing to organize the monitoring of town meetings. It is important that our members and citizens be vigilant about the changes occurring in our towns and that we are represented when proposals are considered. Trump's Seven Springs project and the Rippowam High School Project continue to be concerns on issues of water quality and traffic. Both projects have attracted considerable publicity and community interest. The issues will not be easily resolved.

Land Preservation

In November, Bedford joined six other communities in passing its own open space initiative by a two-to-one margin. The initiative will collectively raise \$17 million in open space funds for Westchester County. The successful outcome of the referendum can be traced to the efforts of Caroline Niemczyk, the Bedford Garden Club and the Bedford Coalition three years ago. Could we have imagined back then that a candidate for Town Supervisor would have chosen conservation as his lead platform? We are grateful to club member, Mrs. Waller, for her important donation of an easement on 64 acres of Tanrackin Farm. Together with Amy and Brian Pennington's 64 acres behind the former Shannon Stables, over 150 acres of Bedford heartland has been preserved.

Community Garden

Plans are moving ahead for the installation of planters along the outside wall of the Fox Senior Center in Mount Kisco. Designed by Ann Catchpole-Howell and built by OBEX, the project will accomplish three worthy goals: 1) to provide access to gardening for those without; 2) to enhance the appearance of a building using horticulture and 3) to demonstrate uses for the products of our recycling program at Obex. The planters will be maintained by the seniors at the Fox Center and the Beautification Committee of Mount Kisco.

February Lecture

Shepherd Ogden of the Cook's Garden and Seed Catalogue educated members about genetically modified organisms (GMO's) and the potential threats they pose to our food chain and environment. He effectively demystified the science concerning GMO's and educated us as to why we should be cautious consumers and activists who demand that more testing is necessary before GMO's become a staple of our food supply. Shepherd travels extensively around the world to lecture on this topic and to locate seeds for his collection that are not genetically modified.

OBEX and Adopt-A-Road

We thank all the volunteers who continue to supply OBEX with plastic materials for recycling and those who cart it to Stamford. We also thank those who participated in the Adopt-A-Road effort along Route 22 that keeps the main artery through Bedford looking beautiful. Each of these efforts provides a wonderful service and reinforces the club's important mission within the community.

Audubon Sanctuaries

The Marsh Sanctuary

The Marsh Sanctuary is a 126 acre nature preserve in the towns of Bedford, Mt. Kisco and New Castle. The secondary mission is to provide an active resource for our community by restoring the Sarles Street buildings and by maintaining the hiking trails and restoring the Brookside Amphitheatre.

PROGRAMS

Our second year as co-chairmen of programs ran smoothly with a greater variety in the kinds of programs offered and strong attendance at almost all meetings. During the course of the year we used some new program locations and had more joint meetings with local clubs.

September 20, 2000

Our first lecture of the season was given by Martha Stewart, ubiquitous maven of all things associated with hearth and home. BY-LAWS OF THE BEDFORD GARDEN CLUB, INC.

1988

The BEDFORD GARDEN CLUB wrote its first By-laws in 1911. It is one of the twelve Founder Clubs which in 1913 founded The Garden Club of America.

Article I

Name

This Association shall be known as the BEDFORD GARDEN CLUB, INC.

Article II

Object

The object of the Club shall be to stimulate knowledge and love of gardening among amateurs, to aid in the protection of native plants and birds, and to encourage civic planting and conservation.

Article III

Directors

- 1. The control and conduct of the property and business of the Club shall be vested in a Board of Directors comprised of six members. All directors shall be elected annually by a majority vote of the members of the Club present, or by proxy, at the Annual Meeting of members, including any adjournment thereof, except that vacancies occurring during the year may be temporarily filled by the Board until the next Annual Meeting of members.
- 2. Meetings. The Board of Directors shall meet annually immediately following the Annual Meeting of Members and shall elect officers.* The Board of Directors shall meet at such other dates throughout the year as it may determine.

^{*} Incorporation requires a Board of Directors. The membership elects the directors, who then elect the officers. However, the Nominating Committee, in proposing candidates for the Board, will recommend those whom they propose for specific office (to be shown in parentheses on the slate). It can be assumed that the recommendations of the membership will be followed by the Board.

The Board of Directors will consult with and work with the Executive Committee as described in our By-laws.

3. Quorum of Board of Directors. Fifty percent of the Board of Directors shall constitute a quorum for the transaction of business in any meeting of the directors.

Officers

The officers of the Club shall be a President, a Vice-President, a Second Vice-President, a Corresponding Secretary, a Recording Secretary, and a Treasurer, who shall be elected by the Board of Directors to serve two years or until their successors are elected. Three officers, the President, First Vice-President, and Corresponding Secretary, shall be elected on the odd year; the Second Vice-President, the Recording Secretary, and the Treasurer on the even year. No President shall hold office for more than four years in succession.

Article IV

President

The President shall preside at all meetings of the Club, and shall be an ex-officio member of all committees except the Nominating Committee. She shall be Chairman of the Executive Committee, shall appoint the Chairmen of all Committees, shall arrange for the orientation of new members, and shall perform such other duties as may be assigned to her by action of the Club or the Executive Committee, and as pertain to the Office of President, including acting as a legal Trustee of all Club finances. The Vice-President, or in her absence the Second Vice-President, shall have all the powers and shall perform all the duties of the President in case of her absence or disability.

Article V

Treasurer

The Treasurer shall be custodian of all funds, shall disburse all money, shall collect all dues and receive donations and income from special projects. She shall also act as a legal Trustee of all Club finances. She shall present a report at all Regular Meetings, and a duly audited Annual Report at the Annual Meeting.

Article VI

Secretaries

The Corresponding Secretary shall give notice of all meetings, shall conduct the correspondence of the Club and notify the Garden Club of America of any changes in membership.

The Recording Secretary shall keep the minutes of the meetings, and act as a legal Trustee of all Club finances.

Article VII

Executive Committee

- 1. The Executive Committee shall consist of the six officers of the Club (the Board of Directors), the Chairmen of all Standing Committees, four members from the Club at large, and upon invitation of the Executive Committee, the Chairmen of Special Committees. In the absence of the Chairman of a Standing Committee or a Special Committee, the Committee's Vice-Chairman shall serve. Subject to these By-laws and to any action taken by the members of the Club at any Annual or Special Meeting, the affairs and business of the Club, the electing of its members and the disbursement of its funds shall be in charge of this Committee.
- 2. The four members from the Club at large shall be elected at the Annual Meeting to serve for one year only, or until their successors are elected.
- 3. During the year, there must be a minimum of eight monthly meetings of the Executive Committee, and five days' written notice shall be given to each member. Seven of its members shall constitute a quorum. Special Meetings may be called by the President or any five members of the Committee.
- 4. The Executive Committee or the President shall submit at each regular meeting of the Club a short report of the affairs of the Club, or such report as the Club may direct.
- 5. The Board of Directors shall have power, in case of a vacancy in any office provided for under Article III or in the elected membership of the Executive Committee, to fill the vacancy for the unexpired term.
- 6. Any member who has special business she may wish to present to the Executive Committee, is privileged to bring it before a meeting of the Executive Committee, after having notified the Corresponding Secretary of her intention.
- 7. The Executive Committee shall have power to deal with all infringements of the rules of the Club.
- 8. (a) An officer of the Club who shall be absent for three successive meetings without providing a report or explanation satisfactory to the Executive Committee shall be deemed to have resigned.

- (b) If a Standing Committee is not represented at three successive meetings by a Chairman or Vice-Chairman or by a report of the Committee presented by the Secretary, the Chairman of such Committee shall have deemed to have resigned.
- (c) A member at large must present an explanation satisfactory to the Executive Committee for her absence from three successive meetings.
- 9. Order of business for the Executive Committee shall be as follows:
 - Minutes of the Committee.
 - Treasurer's Report.
 - Reports of both Secretaries.
 - Reports of Standing Committees.
 - Election of new members.
 - Reports of Special Committees.
 - Unfinished business.
 - New business.

Article VIII

Nominating Committee

- 1. This Committee shall consist of five members. The Chairman shall be appointed in October by the President in consultation with the Executive Committee. Two members shall be appointed from the Executive Committee and three from the Club at large. The Chairman will become a member of the Executive Committee. She and her committee will serve for that calendar year.
- 2. The Committee shall nominate a ticket of candidates for the Board of Directors and four members at large and shall notify the Corresponding Secretary, who shall mail a list of candidates so nominated to each member of the Club at least ten days before the Annual Meeting. This committee may also assist the President or President-elect in appointments of all Standing and Special Committees.

Article IX

Custodian

There will be a Custodian, appointed by the President, whose duties it shall e to have the care and custody of all files, records and archives and all other properties of the Club (except funds and securities) when turned over to her by the Officers and Chairmen of Committees.

Article X

Standing Committees

The Chairman of each Standing Committee shall be appointed by the President as soon as may be after the Annual Meeting and announced at the next regular meeting of the members. The members of each Standing Committee shall be appointed by the Chairman of such Committee after consultation with the President.

There shall be the following Standing Committees:

- 1. Program It shall be the duty of this Committee to arrange programs for all meetings covering and consistent with the work and interests of the Standing Committees, and other interests and projects of the Club, to arrange dates and places of meetings subject to the approval of the Executive Committee, and to prepare notices of meetings for the Corresponding Secretary three weeks in advance.
- 2. Membership It shall be the duty of this Committee to receive the names of candidates for membership, to pass on the eligibility of the candidates and to present their names to the Executive Committee, and to inform the Treasurer and Corresponding Secretary of any changes in membership.
- 3. Exhibitions (Known as Flower Show by GCA). It shall be the duty of this Committee to be responsible for flower arranging and for providing workshops for the members. There shall be at least one exhibition each year.
- 4. Conservation and Civic Affairs It shall be the duty of this Committee to encourage the wise use and sound management of our natural resources both locally and nationally; to encourage the setting aside and maintenance of natural areas; and to stimulate an interest in conservation in the community. It shall also be the duty of this Committee to have a representative present at meetings of the Town Board, the Planning Board, and the Zoning Board of Appeals, when the subject of its meeting is relative to the interests and objectives of the Club. It should acquaint itself with the local zoning ordinances, and keep the Club informed of pertinent pending changes or variances, promote interest in community betterment by such projects as roadside and other civic planting, control of litter, elimination of billboards, etc., and work to preserve the integrity, stability and beauty of this area.
- 5. Horticulture It shall be the duty of this Committee to stimulate the knowledge and love of horticulture among the members; to institute courses in horticulture for members, and to cooperate with local horticulture programs.

Article XI

<u>Meetings</u>

1. Annual Meeting – The Club shall hold on Annual Meeting of the members for the election of Directors and the four members of the Executive Committee from the Club at large and for the transaction of such other business as may come before the meeting. This meeting shall be held in June at such date, hour and place as may be designated by the Board of Directors. Order of business for the Annual Meeting shall be as follows:

Minutes of last Annual Meeting.

Treasurer's Report.

Reports of both secretaries.

Reports of Standing Committees.

Reports of such special Committees as may be designated by the President.

Unfinished business.

President's Report.

Report of the Nominating Committee.

Election of Board of Directors and Members at Large.

Nominations from the floor may precede the elections and a plurality of votes shall elect.

New business.

2. Regular Meetings – A minimum of seven Regular Meetings shall be held each year. The places and the dates proposed by the Program Committee shall be approved by the Executive Committee.

Order of Business for Regular Meetings shall be as follows:

Minutes of last meeting.

Treasurer's Report.

Any reports at the direction of the President.

- 3. At least ten days' notice in writing shall be given each member of all meetings except Special Meetings.
- 4. Special Meetings Special Meetings may be called by the President or at the written request of any five members, sent to the Corresponding Secretary, stating the object for which such meeting is called. The Corresponding Secretary shall notify all members in writing of the date and object of such meeting, giving not

less than three days' notice, and no other business than that stated in the notice shall be transacted at a Special Meeting.

- 5. Twenty-five members shall constitute a quorum at all meetings of the Club.
- 6. Members who shall fail to attend the meetings of the Club for three consecutive meetings without satisfactory explanation in writing to the Corresponding Secretary may be dropped from membership in the Club except as provided under Article VII, Section 7.

Article XII

Members

- 1. Admission to membership in the Club shall be limited to those owning property and residing in Northern Westchester County, or renting in this area for a minimum of two years, and exhibiting a strong interest in horticulture, flower arranging, or conservation and civic affairs.
- 2. The total membership excluding Honorary, Privileged and Affiliate Members shall not exceed our quota of 125 members of which the total of Associate Members shall not exceed 25 and the combined total of Active and Sustaining Members shall not exceed 100.
- 3. There shall be six classes of membership:
 - a. Honorary Members. Persons of Distinction who have rendered outstanding service to the Club over a period of years and so are eligible for this high honor.
 - b. Active Members. This category constitutes the working members of the Club. They shall attend meetings regularly, serve on committees, and take part in the projects of the Club.
 - c. Associate Members. Associate Members shall have full privileges of the Club, including the power of voting. Their attendance at the Regular Meetings and participation in any active work of the Club is optional. Associate Members shall not exceed 25 in number and shall be limited to those who have been Active Members of the Club for at least 10 years and have served with distinction.
 - d. Sustaining Members. Members who have completed ten years of satisfactory service and who are no longer desirous or able to participate in our Club's activities, are eligible for this membership at the discretion of the Executive Committee. These members shall have the privilege of attending Garden Club of America lectures, open teas, obtaining Visiting Garden information and will receive the Bulletin. They may attend meetings of the Bedford Garden Club but may not vote, chair any of the five Standing Committees, or hold office.
 - e. Affiliate Members. Affiliate Membership may be granted at the discretion of her Club's Board to any member in good standing who has moved to another area or who is no longer active because of a compelling reason.

- 1. An Affiliate member may not represent her Club as a delegate of a Zone or Annual Meeting.
- 2. The Bedford Garden Club Affiliate Member is an active member of The Garden Club of America. She may attend lectures, enjoy the use of the Headquarters, have Visiting Garden privileges and receive the Garden Club of America Bulletin. She may attend all Bedford Garden Club functions but may not vote, chair any committee or hold office.
- f. Privileged Membership shall be granted to any person, male or female, who has been helpful to and shown interest in the Bedford Garden Club, but is not eligible for regular membership. This membership shall not exceed seven in number at any one time. These members shall be proposed to the Membership Committee in the usual way and acted upon in conjunction with the Executive Committee. They may participate in Club activities and attend meetings, but they shall not hold office or be eligible to vote. They shall not be considered members of the Garden Club of America and shall not pay dues.

Article XIII

New Members

- 1. The first step in proposing a new member is to contact the Membership Committee Chairman who will explain the procedure.
- 2. A candidate of membership shall be proposed and seconded in writing by members of the Club. The letters of the proposer and seconder together with three letters from members by whom the candidate is well known shall be sent to the Chairman of the Membership Committee. The six officers and those on the Membership Committee may not write these recommendations.
- 3. A member may propose only one and second only one candidate for membership and may write only three endorsing letters during a Club year. A member may not write for a relative for membership in the Club. A member may not propose, second or endorse names for membership until she herself has been a member for one year.
- 4. Candidates shall be considered by the Membership Committee in the order of the submission of their names together with the letters of their proposers, seconders and three endorsing letters as above provided, and no candidate shall be considered until all the requirements of this By-law shall have been complied with.

- 5. Former members and children of former or present members whose names are proposed for membership shall be considered prior to other candidates. Former members who desire to be reinstated need only be proposed and seconded in writing by members. The six Officers and those on the Membership Committee may not write these recommendations. Reinstated members shall have the original date of membership, resignation and reentry listed in the Yearbook.
- 6. Candidates duly proposed and presented as provided for above shall be voted on by the Executive Committee for admission to the Club. Voting shall be by secret ballot. Two adverse votes shall exclude.
- 7. Active Members are expected to serve on one of the following committees: Horticulture, Exhibitions, or Conservation and Civic Affairs unless excused by the Executive Committee for extenuating circumstances.
- 8. In conformity with the Garden Club of America policy regarding dual membership, incoming members of the Bedford Garden Club shall not hold membership in two Garden Club of America's Clubs situated in one locality.

Article XIV

Resignation

Resignation from membership shall be made to the Membership Chairman in writing.

Article XV

Annual Dues

Dues are subject to change at the discretion of the Executive Committee and the Garden Club of America.

All dues include the dues of the Garden Club of America. All members who shall have failed to pay these dues within a month of the second notice shall cease to be members of the Club, except as provided under Article VII, Section 7.

Article XVI

Guests

Members may bring their house guests to any meeting of the Club except Annual or Special Meetings. Persons living in the neighborhood who are not members of the Bedford Garden Club are not entitled to attend meetings except with the approval of the Membership Chairman and the President. The Hostess should be consulted when a meeting is held in a member's house.

Article XVII

Amendments

These By-laws may be amended at an Annual or Special Meeting by a two-thirds vote of those present and voting. No amendment shall be considered unless the Corresponding Secretary shall have mailed a copy thereof to each member of the Club at least ten days before the meeting.

Article XVIII

Disposition of Funds

No part of the assets of the Club shall inure to the benefit of any member of the Club. In the event of the dissolution of the Club, all remaining funds shall be turned over to the Garden Club of America.

Article XIX

Policy

Any service rendered to the Club by a member should be provided at cost with no profit to that member.

RESPONSIBILITIES OF HOSTESSES

- (1) It is the responsibility of the Chairman of Hostesses to appoint a Head Hostess and four co-hostesses for each Garden Club meeting, in addition to the member in whose house the meeting is held.
 - (a) In the event that the appointed Head Hostess cannot fulfill her responsibilities, she is expected to get a replacement and report the change to the Chairman of Hostesses at least two months before her assigned meeting.
 - (b) The Head Hostess and her co-hostesses make and work out all details and arrangements involving hospitality for the meeting and tea.
 - (c) The Head Hostess should confer first with the member in whose house the meeting is being held to ascertain what will be needed in the way of chairs, coat racks, flowers, food, china, silver, direction signs, parking attendant and table for the President.
 - (d) The Head Hostess then makes arrangements with her co-hostesses to work out details and decide what will be provided for refreshments. She contacts the Treasurer for money from the Hostess Fund, which is provided through the dues, as an assessment of \$5 per member.
 - (e) The Head Hostess should contact the Corresponding Secretary a few days before the meeting to find out how many acceptances have been received. She should not purchase any plastic cups, napkins, plates, etc., until our supply is exhausted. The Custodian is in charge of these items as well as the large coffee and hot water (for tea) pots, which are needed upon occasions.
- (2) Co-hostesses may be asked to come the morning of the meeting to help set up chairs or to stay after the meeting to help the hostess put her house back in order.
 - (a) If a co-hostess is unable to fulfill her responsibilities, she is to get a substitute and report the change to her Head Hostess at least two months before her assigned meeting.
- (3) Flower arrangements are the responsibility of the hostesses. If the help of the Flower Arranging Committee is desired, it should be requested in plenty of time.
- (4) All members are asked to turn to be hostesses and it is hoped that all meeting and tea arrangements will be kept as simple as possible.
- (5) During their term of office, the President, two Secretaries, Treasurer and Chairmen of Civic Affairs and Conservation, Flower Arranging, Horticulture and Programs will be excluded from being asked to be hostesses.
