The Philipstown Garden Club, New York
June 12 – 14, 2012
"Growing Together"

This year's Zone III meeting, "Growing Together", was organized by The Philipstown Garden Club on June 12 – 14, 2013 and held at The Thayer Hotel in West Point, New York. Leslie Wortmann, BGC President, and Suzanne Bowers, BGC First Vice President attended the meeting. The beautiful Hudson River Valley and historic West Point were perfect backdrops to a lovely and extremely well organized meeting. The Thayer Hotel is a true legend among the Hudson Valley hotels. This landmark hotel has been a celebrated part of American history since 1926 and is listed on the National Registry of Historical Places. Incidentally, we had to keep our photo ID handy at all times in order to enter the grounds of the United States Military Academy.

This year the Bedford Garden Club was not able to contribute to the 2012 Plant Exchange, "Viburnums". Due to our unseasonable weather this year many clubs had difficulty propagating viburnum cuttings which was a problem for our club as well. Each club was asked to provide a beautiful table arrangement, to be displayed on the tables at the Awards Dinner. Ours was graciously provided by Bonnie Trotta. Bonnie did an outstanding job and created a gorgeous arrangement of white lilies and various perennials from her garden. These arrangements were not judged or critiqued but were on display throughout the meeting. Additionally, Carol Bouyoucos entered the Zone III Photography Show, "The Seasons of Trees" and won honorable mention for her beautiful photograph of cherry blossoms.

After a warm welcome from the Co-Chairmen, we listened to an entertaining and informative talk by Katy Moss Warner, an Honorary Member of the Garden Club of America and a member of the Philipstown Garden Club. Katy, a native of Garrison, grew up in the former home of Mrs. Samuel S. Sloane, one of the founding members of the Philipstown Garden Club in 1914. She is currently President Emeritus of the American Horticulture Society and is a Board Member and City Judge of America in Bloom. Katy shared her childhood memories with us and helped us to understand the history and culture of the Hudson River Valley.

Following Katy's talk Katherine Martucci read the Centennial Committee Report and then the group departed for a boat ride on the Hudson and tour of Constitution Island. Upon our return to the Hotel buses left for the Presidents Cocktail Party in the Boscobel Rose Garden. Members of the Philipstown Garden Club hosted us at dinners in their members' homes that evening.

Day two was divided into two very interesting visits and lectures. One group visited Glynwood Farms, dedicated to working at the intersection of the needs of communities and the opportunities available to farmers and landowners. The group listened to the President of Glynwood speak on "Sustainable Farming" in the Hudson River Valley region. The group then toured the beautiful 225-acre working farm. In the afternoon the group visited Stonecrop in Cold Spring, NY where Michael Hagen, the Chief

Horticulturist, spoke about "The making of a Plant Enthusiast's Garden". Stonecrop was originally the home of Anne and Frank Cabot and became a public garden in 1992 under the direction of Caroline Burgess. At its windswept elevation of 1,100 feet in the Hudson Highlands, Stonecrop enjoys a Zone 5 climate. Stonecrop's plant collections and display gardens not only demonstrate what can be achieved by horticultural enthusiasts, but also serve as an educational resource. The group thoroughly enjoyed their tour. At each of these two locations, a Philipstown Garden Club intern spoke about her experience working at Glynwood and at Stonecrop through the generosity of the Philipstown Garden Club. 2011-2012 Branch Out!

Virginia and I are happy to report that *Branch Out!* has been branching out this past year.

In addition to our bi-annual tree sales (125 trees have been sold), we have branched out and are working with community organizations, schools, and the town on civic tree planting projects as follows:

- This spring Branch Out! received approval from the BHRC (Bedford Historical Review Commission) for our succession planting plan for the Village Green. If all goes according to plan, we will plant our trees this fall.
- Last fall the Bedford Hills Neighborhood Association planted a Branch Out! Sugar Maple in the Bedford Hills Memorial Park. It has grown substantially and is well on its way to providing the area with much needed shade.
- Katonah Village Improvement Society ordered 8 Branch Out! trees this spring to be planted in downtown Katonah along the parkway by the library.
- Branch Out! is in an ongoing dialogue with Fox Lane High School about our Branch Out! tree planting plan for the entrance on Rt. 172.
- Kirtley Cameron, the President of the Bedford Historical Society, hosted a neighborhood Branch Out! cocktail party for the homeowners in the Historic Village along Pound Ridge Road. She had a wonderful turn out, with a lot of enthusiasm and at the Homeowners request we have designed a master plan for that part of Pound Ridge Road. We trust the homeowners will be equally enthusiastic about our plan and recommendations and we look forward to updating you on our progress in the fall.
- Branch Out! is applying for a grant from Bedford 2020 to fund tree planting along the commercial corridor of Bedford on Route 22(heading north on Rt.22 the area is from the North Winds kennel past the A&P to the True Value hardware store). Branch Out! trees are starting to line our thoroughfares. Some of the more visible places Branch Out! is branching out in the community are: 3 Yoshino Cherries in front of Renwick Sotheby's, 3 Elm trees in front of John Jay Homestead on Rt.22, and 3 Elm trees in front of Cisqua School on West Patent Road.

Washington D.C. 2012

"What Happened in Washington Cannot Stay in Washington"

What happens when 300 knowledgeable, motivated and energetic GCA delegates from all over the country meet in Washington D.C. for the 2012 Con/NAL meeting to learn how to advocate and be spokeswomen for our planet and for future generations' ability to live healthy, safe lives? Well, they become the next "American Idols". They spend two days learning how to advocate for clean water, healthy oceans, safe food, fragile lands and plants, animals and insects impacted by climate change. They not only clearly give this message to their legislators on Capitol Hill, but bring the dedication to protect the precious gift of our earthly home, to their clubs and communities. What was learned in Washington cannot stay in Washington, but must be shared with GCA Club members and their community.

Among the dizzying number of things learned were:

A) The earth is changing

- 1. Extreme climate conditions negate the traditional "past is prologue" assumption, making future planning in every area more difficult.
- 2. The Defense Department's strategy for our national security is based on concern about the warming climate conditions, and the dangers this will present worldwide.
- 3. We get our power from the sun, through the process of photosynthesis. Today's energy comes from ancient sun power in the form of coal, oil and natural gas, but now we need to figure out how to get our energy from the contemporary sunshine.
- 4. The world is getting wetter and drier, causing both unusual flooding and drought, with rain more intense, yet more infrequent.
- 5. Once-in-a-century weather occurrences are becoming common place.
- 6. Glaciers, on which people worldwide depend on for water, are becoming smaller, producing less water for irrigation and consumptive use.
- 7. Snow is coming later in fall, stopping earlier in the spring.
- 8. Water levels in lakes worldwide continue to drop.
- 9. Each year is hotter than the hottest on record.
- 10. The 2012 USDA Plant Hardiness Zone Map readjusted the traditional zones positions 5 degree north, because of the warming shift.
- 11. Native plant species do not have time to adapt to the rapidly changing climatic conditions, leaving over 4000 species critically at risk.
- 12. Oceans levels are rising and the water is becoming more acidic, threatening to dissolve the shells of sea creatures, like plankton, shrimp, etc.
- 13. Our National Parks System is more important than ever, and must be adequately supported as it nears its 100th anniversary
- B) Importance of fully funding the Land and Water Conservation Fund (LWCF)
- 1. The LWCF was established by Congress in 1964, to use a small portion of the billions of dollars of the fees paid by companies drilling offshore for oil and gas so the depletion of one natural resource, offshore oil and gas, supports the conservation of another precious resource, our land and water.
- 2. The money has been used in all 50 states to acquire land or easements on land for recreational use, protect fragile ecosystems and wetlands restoration, provide

- matching grants for state and local parks and recreation projects, pay farmers to conserve their land and provide other conservation tools.
- 3. But every year except one, Congress has taken money from this popular, vital program for other uses, rather than their intended conservation and recreation purposes, to the detriment of our outdoors.
- 4. Recent polling found that 86% of Americans support the LWCF and more than 77% support fully funding LWCF at its authorized level of \$900 million a year.
- 5. Every dollar of LWCF investment has resulted in \$4 of economic value, with 1 in 20 US jobs having to do with the outdoor recreation industry.

C) The power of women on a mission:

- 1. Senator Kirsten Gillibrand reminded us that women tend to take long term views, looking for the best ideas, so when woman's voices are heard in the boardroom and at political discussions, better solutions result. For instance, GCA members should ask for full disclosure on the effects of fracking, including chemicals used, and question why this activity is exempt from the Clean Air and Water Act, so we can figure out a way to safely extract natural gas
- 2. GCA member, Ellen Rouse Conrad told about how the Bedford Garden Club realized that "nature is not waiting for us" and sponsored an environmental conference which changed their community. They developed a public-private partnership which created a city-wide program, Bedford 2020.org, to reduce energy use, recycle waste, plant trees, preserve their natural resources and create a healthier and more sustainable place to live. The "Summit in a Box" was developed as a template for every community to use to plan for a smarter future.
- 3. GCA member, *Pat Wall*, described the successes of the Portland Garden Club's amazing efforts to protect the beauty of the Columbia River Gorge against development and Indian casinos, and the ongoing vigilance required to preserve this scenic vista
- 4. Senator Mary Landrieu described the Gulf coast "Women of the Storm" movement formed to encourage Congress to pass the RESTORE Act (S.1400), and send 80% of BP fine dollars that may be assessed following the Deepwater Horizon oil spill under the Clean Water Act, back to Gulf Coast states for sustainable housing, safe levees, coastal restoration and to encourage long-range planning along the Gulf Coast.
- 5. *Kathryn Sullivan*, assistant secretary of the National Oceanic and Atmospheric Administration (NOAA) reminded us that the entire world depends on NOAA's very sophisticated and accurate system of scientific climate modeling and weather monitoring, and that our changing climate is the world's greatest challenge. There is an 86% increase in usage of NOAA's climate data for budgeting and future planning by such diverse groups as farmers, home builders, state governments, electrical plants, national military strategists and firefighters. Water and food management depends on understanding what is happening in the atmosphere.
- 6. GCA member *Kathryn Kennedy*, Executive Director of the Center for Plant Conservation, has collected and preserved 750 of America's most imperiled native plant species and works to replant them in appropriate places, before they become extinct. She supports full funding for the Endangered Species Act, especially in the face of the changing climate conditions.

- D) The importance of the Farm Bill, which is voted on every five years:
 - 1. The 2012 Farm Bill is the most important law determining what America eats, because its many sections dictate how we grow food, how we support farmers, how we sell food, and what food assistance programs are available to all Americans.
 - 2. Agriculture is the largest human activity, using 70% of the earth's water, and although less than 1% of the U S our population is involved in farming, more people are now getting into sustainable farming.
 - 3. It is hoped that "Specialty Crops" (all fruits and vegetables) will receive more governmental support as compared to the agri-business crops corn, wheat, sugar cotton and soy, which have historically received large subsidies.
 - 4. Concern over the rapid growth of Genetically Modified Organisms (GMO) 85% soy beans and 70% corn are genetically engineered, which are not sufficiently tested or even labeled by the FDA, although many other countries require GMO labeling.
 - 5. Tax Incentive for Conservation Easements, allowing private landowners to permanently retire development rights to protect significant natural resources, is in danger of being eliminated from the 2012 Farm Bill.
 - 6. "The Local Farms, Food, and Jobs Act" is a USDA package of reforms which strengthen local and regional food systems from farm to table.
 - 7. "Know your Food, Know your Farmer" is an innovative USDA mapping tool that is on line and will be continually updated.
- E) Highways BEE Act should be included in the House Transportation and Infrastructure Bill:
- 1. Seventy-four out of 100 different crop types, or one in every three bites of food we eat, are pollinated.
- 2. Pollinator have decline has become a major environmental issue today. Beehive colony collapse has resulted in an up to 85% decline in bumble bees.
- 3. Humans don't share very well with plants and animals we just take their landscape, create a monoculture (yards or agriculture) with few native plants and then cover our plants with pollinator-killing pesticides.
- 4. The Highways BEE Act (H.R.2381 Highways Bettering the Economy and Environment Act) requires no money, but encourages reduced mowing and native plantings on rights-of-way and adjacent to federal-aid highways, allowing wildflowers and native plants to grow, providing habitat for pollinators, ground nesting birds and other small wildlife saving money on mowing.

HORTICULTURE 2011-2012

The Horticulture Committee activities for the year included several flower show visits, a bulb workshop, a cutting workshop and a member's garden tour.

Our October membership meeting featured Brent Heath from Brent and Becky's Bulbs in Virginia. Brent did a slide presentation about an incredible variety of bulbs. We also gave 3 of the GCA daffodil to each member to plant at home. After the meeting, those members who were interested stayed for a container planting workshop. About 20 members planted Narcissus "Avalanche", Hyacinthus "Carnegie", Tulipa "Calgary", crocus vernus "Jeanne d'Arc" and puschkinia scilloides "Alba". We stored our pots in a cold dark place over winter, watering about once a month. In March, when the weather turned warm we brought them out and had wonderful success.

We also registered for the company's Bloomin' Bucks program which will provide our club with 15% back from any purchases our members make at Brent and Becky's Bulbs. In an effort to get more members familiar with and involved in flower shows we organized groups to visit the Little Garden Club of Rye show in September and the Green Fingers Club of Greenwich show in March.

For our Zone III meeting in June we were asked to bring viburnum plants that we propagated. We held a workshop in February to start hardwood cuttings. About 10 members attended the workshop. Unfortunately none of our cuttings took root. We believe the cause was in part the unusually warm weather we had in March and are afraid they were not kept moist enough.

In May, Debbie attended a Zone sponsored meeting at Native Landscapes Inc. garden center in Pawling, NY. 2011-2012

On January 18, 2012, this Committee reported to BGC membership about GCA scholarship programs and activities. The presentation was about the range and scale of GCA scholarship activities nationwide:

- Scholarships are the part of GCA Outreach which encourages new talent and recognizes outstanding contributions of individuals, some established and some emerging.
- In 2010, more than 55 awards and programs were active, totaling more than \$211,000.
- More than 1000 recipients have received support since the first award in 1928.
- The program recognizes awardees at all academic and professional levels, from undergraduate to doctoral students and practitioners.
- Awards can recognize past accomplishments or support further study.
- Fields include botany, conservation, ecology studies, education, history and design, horticulture and landscape architecture.

GCA encourages local clubs to participate by

- Inviting GCA scholars to meetings as speakers,
- Supporting candidate applications for scholarships, and
- Donating to the General Scholarship Fund or to endowed funds at GCA.

GCA recommends that Scholarships be a separate line item in all club budgets.

We are proud to say that BGC consistently supports GCA Scholarships in this way.

At that meeting, it was suggested that BGC offer to work with Trailside Museum /Ward Pound Ridge, to see if any GCA funds might be available to help Trailside commemorate their 75th anniversary, in recognition of their founding by Delia Marble. Volunteer project, not funding.

Summer Scholarship in Field Botany

GCA and Hunt Scholarships together.

\$2000 per award, for summer study in the field, undergraduate through Masters Degree; deadline Feb. 1

Fellowship in Ecological Restoration.

\$8000 for graduate study and research at a leading accredited university

Fellowship or Internship in Garden History and Design.

Graduate study, or cataloguing archives at Smithsonian.

Fellowship in Conservation (or general) Horticulture.

Programs for South Carolina, middle states, study at "major botanical garden"

Scholarship in Native Bird Habitat.

For college seniors or graduate students \$4000 financial aid to study areas in the United States that provide seasonal habitat for threatened or endangered native birds and to tend useful information for land-management decisions. IN MEMORIUM

Retrospective of a Pioneer Wilhelmine Kirby Waller GCA President 1963-1968

On a cool September morning near the turn of the second millennium, Willie Waller walked out of Tanrackin House onto her driveway and surveyed the landscape: There to her right was the fence and field where mares nuzzled their young. To her left stood the apple orchard; once the scene of Easter egg hunts and games for the farm children. Directly below to the north, along the maple tree-canopied allee, she could see the outdoor riding ring which had recently been installed. Behind her lay the gardens where soon giant pumpkins would be harvested and displayed on the covered porch at the eastern side of the house. This was the season she loved. Even the old dairy farm with its warm, earthy smell and lively collection of neighborhood cats could be evoked through the fall mist of early morning beyond the hill below the farm. Oh how lovely it was! Still busy and productive!

Standing there in the early morning light Willie realized that this was where it had all begun, her happy explorations of the natural world on her grandparents' Tanrackin Farm. How well she remembered her childhood, scouring the winter woods and fields for signs of life: the skunk cabbage sprouts which she carefully measured, the katydid's call predicting rain and the eerie cry of the tree toad as it announced the first frost. When Willie and her parents moved there in her teenage years and later as an adult, she would begin the quest of a lifetime, the passion of a life: to protect the natural world that she had grown to know and to love. Remembering it all, Willie began her morning walk through the farm. She hadn't much time. Garden club ladies were coming for luncheon. They were looking to her for advice and inspiration for a new environmental initiative they wished to launch ...

Wilhelmine Stewart Kirby was born in New York City on January 19, 1914 to Wilhelmine and Gustavus Town Kirby. She was educated at the Chapin School and on April 7, 1942 married Thomas Mercer Waller, the charming Virginian and fellow horseman whom she had met in South Carolina where her parents spent the winter. Tom was the only man she knew who "liked to leave the party early," taking advantage of cool mornings for rides on horseback. Both Willie and Tom remained early risers all their lives as they coexisted peacefully on the Bedford, NY Farm which they now inhabited. Together they operated a highly successful breeding stable and dairy farm, with Tom training their thoroughbreds for the Belmont race track and Willie overseeing her hunters and a new breed of small thoroughbred English ponies.

After her marriage, and in memory of her mother, Willie joined the Bedford Garden Club and became Chairman of its Conservation Committee before assuming its presidency in 1949. By then she knew all about gardening, farming and the natural integration of animals, plants and their surroundings. She would soon publish "The Large Place," a treatise on farming techniques for amateur farmers in the Westchester County area.

She had already managed her own large place with efficiency and skill. Imagine her dismay when Willie learned in the early 1950s that traces of the insecticide DDT had been discovered in the milk of her husband's purebred Guernsey cows. Imagine her distress at noting the waning bird population on the farm after several aerial

sprayings of that strong agent. Intended to do away with the leaf-eating Gypsy Moth, it was wreaking havoc on much other life at Tanrackin. Entreating local officials to resist further applications to her property proved fruitless. Thus began her friendship and professional relationship with Rachel Carson, noted scientist and author whose forthcoming book "Silent Spring" would finally elicit awareness of the devastating effects of DDT and other chlorinated hydrocarbons. Years later Rachel and Willie's efforts were rewarded when in 1972 DDT was banned in America as an agricultural insecticide. For Willie there was now no turning back. She was in the trenches of a war against environmental destruction and would devote her life to that cause. Working as a civic leader in her town, her county, her state and eventually her country, Willie joined countless boards and organizations whose missions were to preserve quality of life by fighting against pollution and over-development. From her work with the Nature Conservancy to service on planning boards, to her efforts on behalf of land stewardship, to membership on the New York State Conservation Committee and including advisory positions to four U.S. presidents, her efforts were tireless. As friend and Executive Director of the Mianus Gorge Conservation Committee Anne Hubbell French said, "When Willie Waller arrived at a meeting, everyone knew that she meant business!" Her business- that of improving the lives of ordinary citizens- was apparent far and wide. Highway beautification, an environmental concern during the Lyndon Johnson administration, was one of Willie's pet projects. With Ridgefield Garden Club member Louise McKeon she testified before Congress and spoke strongly against billboard advertising which marred the new highway system and defaced the landscape. At that time too, she befriended First Lady "Bird" Johnson, and joined in efforts to beautify the nation's capital, encouraging the GCA to take part as well. When she became a member of the Advisory Committee to the Secretary of State for the 1972 United Nations Conference on the Human Environment in Sweden, her work assumed an international

Through it all, however, it was the GCA that held her lifelong devotion. As its president from 1965-68 Willie realized that if The Garden Club of America were to impact environmental legislation into the future, a special committee was needed for research and decision making on the eventual positions it would take. In 1969 The National Affairs and Legislation Committee, originally a subcommittee of Conservation, was formed by Willie for that purpose. She became its first chairman. Today the NAL continues to impact legislative proposals, importantly bringing them to the attention of GCA's membership. In 1972 Willie was awarded GCA's highest recognition, the Frances K. Hutchinson Medal, awarded to the member or non-member of national importance for outstanding service to conservation. Throughout her life it remained the achievement of which she was most proud.

The day began to warm. Basket in hand, Willie proceeded to the lower cutting garden to pick flowers for the dining room table. Her grandfather's ancient Jane Cowl Dahlia tubers still produced enormous blooms, their pale coral flowers nearly overpowering arched stems. Further on grew bright gourds and pumpkins. She would ask one of the farm boys to choose several for her guests. Willie climbed slowly up the hill to the house, passing the pony barn and greeting the dogs who waited, tails wagging energetically, as she rounded the bend.

The house was cool- a relief in the late morning heat. Willie handed her bouquet to Anna, the caregiver who had been with her for so many years. She would know what to

do with them. When she reached the second floor she headed for the office at the end of the hall and opened the filing cabinet whose contents bore witness to a long, productive life. There were letters from the presidents with whom she had worked; Lyndon Johnson, Richard Nixon, Gerald Ford, Ronald Reagan and George H. W. Bush. She leafed through countless Minutes from long ago meetings, photographs, mementos, and her speech accepting the Nature Conservancy's Oak Leaf Award. At last she found what she was looking for. It was filed under the heading: GCA Speeches and Remarks."

Pulling out an old copy of words she had delivered to the Palmetto, Florida garden club in 1989, the year after GCA's seventy-fifth anniversary, she began to read: "Between 1969 and 1972 the GCA became a strong participant in the environmental movement. In those years we helped to win three major victories: the National Environmental Policy Act of 1969 which committed the country to treating the environment sensibly and to forcing federal agencies to file environmental impact statements before spending federal funds on new projects. The Clean Air Act in 1970 committed the country to specific standards for air quality and included regulation on automobile emissions, once considered off limits. The 1972 Water Pollution Amendments set long term goals and specific interim standards for cleaning up the nation's water. We must carry on - looking around us in awareness, joining hands with each other, with business and industry, with local, state and federal authorities - to lift the quality of the areas in which we live. In this way, we will continue to be true to the heritage handed down to us by the founders of The Garden Club of America." She could hear her words as they rang out that day. They resonated still. She would encourage her new garden club friends during lunch and would support them in any way she could. Tucking a copy of her notes under her arm, Willie strode through the hall, down the staircase and attended the ringing doorbell.

Willie Waller's death on April 7, 2004, occurred sixty- two years to the day, after her marriage to Tom. She had recently celebrated her 90th birthday. Her passion for the earth and her determination to save it have resulted in the enduring efforts of the GCA to protect our world. This larger than life woman, who so strongly believed in the Garden Club of America, will long be remembered.

BY-LAWS OF THE BEDFORD GARDEN CLUB, INC.

Last Revised 2011

The BEDFORD GARDEN CLUB wrote its first By-laws in 1911. It is one of the twelve Founder Clubs which in 1913 founded The Garden Club of America.

Article I

Name

This Association shall be known as the BEDFORD GARDEN CLUB, INC.

Article II

Object

The object of the Club shall be to stimulate knowledge and love of gardening among amateurs, to aid in the protection of native plants and birds, and to encourage civic planting and conservation.

Article III

Directors

- 1. The control and conduct of the property and business of the Club shall be vested in a Board of Directors comprised of six members. All directors shall be elected annually by a majority vote of the members of the Club present, or by proxy, at the Annual Meeting of members, including any adjournment thereof, except that vacancies occurring during the year may be temporarily filled by the Board until the next Annual Meeting of members.
- 2. Meetings. The Board of Directors shall meet annually immediately following the Annual Meeting of Members and shall elect officers.* The Board of Directors shall meet at such other dates throughout the year as it may determine.

^{*} Incorporation requires a Board of Directors. The membership elects the directors, who then elect the officers. However, the Nominating Committee, in proposing candidates for the Board, will recommend those whom they propose for specific office (to be shown in parentheses on the slate). It can be assumed that the recommendations of the membership will be followed by the Board.

The Board of Directors will consult with and work with the Executive Committee as described in our By-laws.

3. Quorum of Board of Directors. Fifty percent of the Board of Directors shall constitute a quorum for the transaction of business in any meeting of the directors.

Officers

The officers of the Club shall be a President, a Vice-President, a Second Vice-President, a Corresponding Secretary, a Recording Secretary, and a Treasurer, who shall be elected by the Board of Directors to serve two years or until their successors are elected. Three officers, the President, First Vice-President, and Corresponding Secretary, shall be elected on the odd year; the Second Vice-President, the Recording Secretary, and the Treasurer on the even year. No President shall hold office for more than four years in succession.

Article IV

President

The President shall preside at all meetings of the Club, and shall be an ex-officio member of all committees except the Nominating Committee. She shall be Chairman of the Executive Committee, shall appoint the Chairmen of all Committees, shall arrange for the orientation of new members, and shall perform such other duties as may be assigned to her by action of the Club or the Executive Committee, and as pertain to the Office of President, including acting as a legal Trustee of all Club finances. The Vice-President, or in her absence the Second Vice-President, shall have all the powers and shall perform all the duties of the President in case of her absence or disability.

Article V

Treasurer

The Treasurer shall be custodian of all funds, shall disburse all money, shall collect all dues and receive donations and income from special projects. She shall also act as a legal Trustee of all Club finances. She shall present a report at all Regular Meetings and a duly audited Annual Report at the Annual Meeting.

Article VI

Secretaries

The Corresponding Secretary shall give notice of all meetings, shall conduct the correspondence of the Club and notify the Garden Club of America of any changes in membership.

The Recording Secretary shall keep the minutes of the meetings, and act as a legal Trustee of all Club finances.

Article VII

Executive Committee

- 1. The Executive Committee shall consist of the six officers of the Club (the Board of Directors), the Chairmen of all Standing Committees, four members from the Club at large, and upon invitation of the Executive Committee, the Chairmen of Special Committees. In the absence of the Chairman of a Standing Committee or a Special Committee, the Committee's Vice-Chairman shall serve. Subject to these By-laws and to any action taken by the members of the Club at any Annual or Special Meeting, the affairs and business of the Club, the electing of its members and the disbursement of its funds shall be in charge of this Committee.
- 2. The four members from the Club at large shall be elected at the Annual Meeting to serve for one year only, or until their successors are elected.
- 3. During the year, there must be a minimum of six monthly meetings of the Executive Committee, and five days' written or electronic notice shall be given to each member. Seven of its members shall constitute a quorum. Special Meetings may be called by the President or any five members of the Committee.
- 4. The Executive Committee or the President shall submit at each regular meeting of the Club a short report of the affairs of the Club, or such report as the Club may direct.
- 5. The Board of Directors shall have power, in case of a vacancy in any office provided for under Article III or in the elected membership of the Executive Committee, to fill the vacancy for the unexpired term.
- 6. Any member who has special business she may wish to present to the Executive Committee, is privileged to bring it before a meeting of the Executive Committee, after having notified the Corresponding Secretary of her intention.
- 7. The Executive Committee shall have power to deal with all infringements of the rules of the Club.
- 8. (a) An officer of the Club who shall be absent for three successive meetings without providing a report or explanation satisfactory to the Executive Committee shall be deemed to have resigned.
 - (b) If a Standing Committee is not represented at three successive meetings by a Chairman or Vice-Chairman or by a report of the Committee presented by the Secretary, the Chairman of such Committee shall have deemed to have resigned.

- (c) A member at large must present an explanation satisfactory to the Executive Committee for her absence from three successive meetings.
- 9. Order of business for the Executive Committee shall be as follows:
 - Minutes of the Committee.
 - Treasurer's Report.
 - Reports of both Secretaries.
 - Reports of Standing Committees.
 - Election of new members.
 - Reports of Special Committees.
 - Unfinished business.
 - New business.

Article VIII

Nominating Committee

- 1. This Committee shall consist of five members. The Chairman shall be appointed in October by the President in consultation with the Executive Committee. Two members shall be appointed from the Executive Committee and three from the Club at large. The Chairman will become a member of the Executive Committee. She and her committee will serve for that calendar year.
- 2. The Committee shall nominate a ticket of candidates for the Board of Directors and four members at large and shall notify the Corresponding Secretary, who shall mail a list of candidates so nominated to each member of the Club at least ten days before the Annual Meeting. This committee may also assist the President or President-elect in appointments of all Standing and Special Committees.

Article IX

Custodian

There will be a Custodian, appointed by the President, whose duties it shall be to have the care and custody of all files, records and archives and all other properties of the Club (except funds and securities) when turned over to her by the Officers and Chairmen of Committees.

Article X

Standing Committees

The Chairman of each Standing Committee shall be appointed by the President as soon as may be after the Annual Meeting and announced at the next regular meeting of the members. The members of each Standing Committee shall be appointed by the Chairman of such Committee after consultation with the President.

There shall be the following Standing Committees:

- 1. Program It shall be the duty of this Committee to arrange programs for all meetings covering and consistent with the work and interests of the Standing Committees, and other interests and projects of the Club, to arrange dates and places of meetings subject to the approval of the Executive Committee, and to prepare notices of meetings for the Corresponding Secretary three weeks in advance.
- 2. Membership It shall be the duty of this Committee to receive the names of candidates for membership, to pass on the eligibility of the candidates and to present their names to the Executive Committee, and to inform the Treasurer and Corresponding Secretary of any changes in membership.
- 3. Exhibitions (Known as Flower Show by GCA). It shall be the duty of this Committee to be responsible for flower arranging and for providing workshops for the members. There shall be at least one exhibition each year.
- 4. Conservation and Civic Affairs It shall be the duty of this Committee to encourage the wise and sound management of our natural resources both locally and nationally; to encourage the setting aside and maintenance of natural areas; to stimulate an interest in conservation in the community; to promote interest in community improvement and to work to preserve the integrity, stability and beauty of this area.
- 5. Horticulture It shall be the duty of this Committee to stimulate the knowledge and love of horticulture among the members; to institute courses in horticulture for members, and to cooperate with local horticulture programs.
- 6. Garden History and Design it shall be the duty of this Committee to educate the Members about American landscape and garden design, to demonstrate how American Garden history is and has always been an integral part of the cultural and social life of the communities in which these gardens exist, and to continue to add to the GCA Collection at the Archives of American Gardens by researching, documenting and photographing important American gardens past and present, large and small, simple or complex, classical or vernacular.

Article XI

Meetings

1. Annual Meeting – The Club shall hold an Annual Meeting of the members for the election of Directors and the four members of the Executive Committee from the Club at large and for the transaction of such other business as may come before the meeting. This meeting shall be held in June at such date, hour and place as may be designated by the Board of Directors. Order of business for the Annual Meeting shall be as follows:

Minutes of last Annual Meeting.

Treasurer's Report.

Reports of both secretaries.

Reports of Standing Committees.

Reports of such special Committees as may be designated by the President.

Unfinished business.

President's Report.

Report of the Nominating Committee.

Election of Board of Directors and Members at Large.

Nominations from the floor may precede the elections and a plurality of votes shall elect.

New business.

2. Regular Meetings – A minimum of seven Regular Meetings shall be held each year. The places and the dates proposed by the Program Committee shall be approved by the Executive Committee.

Order of Business for Regular Meetings shall be as follows:

Minutes of last meeting.

Treasurer's Report.

Any reports at the direction of the President.

3. At least ten days' written or electronic notice shall be given each member of all meetings except Special Meetings.

- 4. Special Meetings Special Meetings may be called by the President or at the written request of any five members, sent to the Corresponding Secretary, stating the object for which such meeting is called. The Corresponding Secretary shall notify all members in writing of the date and object of such meeting, giving not less than three days' notice, and no other business than that stated in the notice shall be transacted at a Special Meeting.
- 5. Twenty-five members shall constitute a quorum at all meetings of the Club.
- 6. Our Club depends on the active participation of its membership. Members are expected to attend the monthly meetings and to be active in the Standing Committee of their choosing. Members are asked to support and respect the work of their fellow members who organize and plan for each Bedford Garden Club event. In the instance where it is not possible to attend meetings on a regular basis, members are asked to contribute to the Club in ways that will be mutually beneficial.

Article XII

Members

- 1. Admission to membership in the Club shall be limited to those owning property and residing in Northern Westchester County, or renting in this area for a minimum of two years, and exhibiting a strong interest in horticulture, flower arranging, or conservation and civic affairs or garden history and design.
- 2. The total membership excluding Affiliate Members shall not exceed our quota of 125 members of which the total of Associate Members shall not exceed 25 and the combined total of Active and Sustaining Members shall not exceed 100.
- 3. There shall be four classes of membership:
 - a. Active Members. This category constitutes the working members of the Club. They shall attend meetings regularly, serve on committees, and take part in the projects of the Club.
 - b. Associate Members. Associate Members shall have full privileges of the Club, including the power of voting. Their attendance at the Regular Meetings and participation in any active work of the Club is optional. This category of membership shall not exceed 25 in number and shall be limited to any member who has served as a President of the Bedford Garden Club and/or has served on the zone or national level of the GCA.

- c. Sustaining Members. Members who have completed fifteen years of satisfactory service and who are no longer desirous or able to participate in our Club's activities, are eligible for this membership at the discretion of the Executive Committee. These members shall have the privileges offered by the Garden Club of America. They may attend meetings of the Bedford Garden Club and elect to chair a committee, vote or hold an office if they desire.
- d. Affiliate Members. Affiliate Membership may be granted upon request to any member in good standing who has moved to another area.
 - 1. An Affiliate member may not represent her Club as a delegate of a Zone or Annual Meeting.
 - 2. The Bedford Garden Club Affiliate Member is an active member of The Garden Club of America and shall have the privileges offered by the Garden Club of America. The Affiliate Member may attend Bedford Garden Club functions but may not vote, chair any committee or hold office.

Article XIII

New Members

- 1. The first step in proposing a new member is to contact the Membership Committee Chairman who will explain the procedure.
- 2. A candidate of membership shall be proposed and seconded in writing by members of the Club. The letters of the proposer and seconder together with three letters from members by whom the candidate is well known shall be sent to the Chairman of the Membership Committee. Those on the Membership Committee may not write these recommendations.
- 3. A member may propose only one and second only one candidate for membership and may write only three endorsing letters during a Club year. A member may not write for a relative for membership in the Club. A member may not propose, second or endorse names for membership until she herself has been a member for six months.
- 4. Candidates shall be considered by the Membership Committee in the order of the submission of their names together with the letters of their proposers, seconders and three endorsing letters as above provided, and no candidate shall be considered until all the requirements of this By-law shall have been complied with.

- 5. Former members and children of former or present members whose names are proposed for membership shall be considered prior to other candidates. Former members who desire to be reinstated need only be proposed and seconded in writing by members. The six Officers and those on the Membership Committee may not write these recommendations. Reinstated members shall have the original date of membership, resignation and reentry listed in the Yearbook.
- 6. Candidates duly proposed and presented as provided for above shall be voted on by the Executive Committee for admission to the Club. Voting shall be by secret ballot. Two adverse votes shall exclude.
- 7. Active Members are expected to serve on at least one of the following committees: Horticulture, Exhibitions, or Conservation and Civic Affairs or Garden History and Design unless excused by the Executive Committee for extenuating circumstances.
- 8. In conformity with the Garden Club of America policy regarding dual membership, incoming members of the Bedford Garden Club shall not hold membership in two Garden Club of America's Clubs situated in one locality.

Article XIV

Resignation

Resignation from membership shall be made to the Membership Chairman in writing.

Article XV

Annual Dues

Dues are subject to change at the discretion of the Executive Committee and the Garden Club of America.

All dues include the dues of the Garden Club of America. All members who shall have failed to pay these dues within a month of the second notice shall cease to be members of the Club, except as provided under Article VII, Section 7.

Article XVI

Guests

Members may bring their house guests to any meeting of the Club except Annual or Special Meetings. Persons living in the neighborhood who are not members of the Bedford Garden Club are not entitled to attend meetings except with the approval of the Membership Chairman and the President. The Hostess should be consulted when a meeting is held in a member's house.

Article XVII

Amendments

These By-laws may be amended at an Annual or Special Meeting by a two-thirds vote of those present and voting. No amendment shall be considered unless the Corresponding Secretary shall have mailed or electronically mailed a copy thereof to each member of the Club at least ten days before the meeting.

Article XVIII

Disposition of Funds

No part of the assets of the Club shall inure to the benefit of any member of the Club. In the event of the dissolution of the Club, all remaining funds shall be turned over to the Garden Club of America.

Article XIX

Policy

Any service rendered to the Club by a member should be provided at cost with no profit to that member.

RESPONSIBILITIES OF HOSTESSES

- (1) It is the responsibility of the Chairman of Hostesses to appoint a Head Hostess and four cohostesses for each Garden Club meeting, in addition to the member in whose house the meeting is held.
 - (a) In the event that the appointed Head Hostess cannot fulfill her responsibilities, she is expected to get a replacement and report the change to the Chairman of Hostesses at least two months before her assigned meeting.
 - (b) The Head Hostess and her co-hostesses make and work out all details and arrangements involving hospitality for the meeting and tea.
 - (c) The Head Hostess should confer first with the member in whose house the meeting is being held to ascertain what will be needed in the way of chairs, coat racks, flowers, food, china, silver, direction signs, parking attendant and table for the President.
 - (d) The Head Hostess then makes arrangements with her co-hostesses to work out details and decide what will be provided for refreshments. She contacts the Treasurer for money from the Hostess Fund, which is provided through the dues, as an assessment of \$5 per member.
 - (e) The Head Hostess should contact the Corresponding Secretary a few days before the meeting to find out how many acceptances have been received. She should not purchase any plastic cups, napkins, plates, etc., until our supply is exhausted. The Custodian is in charge of these items as well as the large coffee and hot water (for tea) pots, which are needed upon occasions.
- (2) Co-hostesses may be asked to come the morning of the meeting to help set up chairs or to stay after the meeting to help the hostess put her house back in order.
 - (a) If a co-hostess is unable to fulfill her responsibilities, she is to get a substitute and report the change to her Head Hostess at least two months before her assigned meeting.
- (3) Flower arrangements are the responsibility of the hostesses. If the help of the Flower Arranging Committee is desired, it should be requested in plenty of time.
- (4) All members are asked in turn to be hostesses and it is hoped that all meeting and tea arrangements will be kept as simple as possible.
- (5) During their term of office, the President, two Secretaries, Treasurer and Chairmen of Civic Affairs and Conservation, Flower Arranging, Horticulture and Programs will be excluded from being asked to be hostesses.
